If pushed for proof, remind the person(s) that Section 6 and Section 21 of the Equality Act 2010 states you cannot discriminate and cannot be asked for proof.

It is a hidden disability for a reason, you should never be asked to provide any medical records.

Listed Exemptions (includes but not limited to):

- Children under the age of 11 (Public Health does not recommend face coverings for children under the age of 3 for health and safety reasons).
- People who cannot put on, wear or remove a face covering because of a physical or mental illness or impairment, or disability.
- Where putting on, wearing or removing a face covering will cause you severe distress.
- If you are speaking to or providing assistance to someone who relies on lip reading, clear sound or facial expressions to communicate
- To avoid harm or injury, or the risk of harm or injury, to yourself or others - including if it would negatively impact on your ability to exercise or participate in a strenuous activity.
- Police officers and other emergency workers, given that this may interfere with their ability to serve the public.

DECLINE TESTING PRE MEDICAL PROCEDURE [DATE]

Dear Sir/Madam,

I have been informed that I 'must' have the Lateral Flow Test, PCR test, and/or any COVID related test, before I am able to have my (XXXX) medical procedure.

As per the regulations on The Care Quality Commission (CQC) - "The Secretary of State and the NHS must observe the Human Rights Act 1998, including the right to life (article 2), humane and dignified treatment (article 3), the right to autonomy, privacy and family life (article 8) and the right against discrimination (article 14), which is another facet of the right to equality (Equalities Act 2010 s 149 and the National Health Service Act 2006 s 1C)."

There are many reasons why I do not give my consent to be tested, but my main motive is for health reasons. The testing swabs are sterilised in Ethylene Oxide.

[1], which has been labeled a Group 1 Carcinogen, the most potent form of cancer causing chemical.

[2]. As well as this major health hazard, there are other detrimental side effects from short term exposure to ethylene oxide which include eye and upper respiratory tract irritation, nausea, vomiting, diarrhoea, headache, dizziness, malaise, fatigue, muscle weakness, and signs and symptoms of peripheral neuropathy.

[3]. Lateral flow testing is extremely unreliable - "University of Birmingham and Scottish universities suggesting that the lateral flow tests had a sensitivity of just 3% (the proportion of people with covid-19 who tested positive) and that 58% of the positives were false positives."

[4] As well as being very unreliable, it is not even a medically accurate form of testing. "Previous data from the Liverpool mass testing pilot programme

found that lateral flow tests detected just 48.89% of covid-19 infections in asymptomatic people when compared with a polymerase chain reaction (PCR) test. It also found that the Innova Lateral Flow SARS- CoV-2 antigen test failed to detect three in 10 cases with the highest viral loads."

[5] A minister at the Department of Health and Social Care admitted that mass swab testing was "not an accurate way of screening the general population" and could provide false reassurance.

[6] In another study by Public Health England, published in the British Medical Journal, it states - "The absence of strong evidence that asymptomatic people are a driver of transmission is another good reason for pausing the roll out of mass testing in schools, universities, and communities."

[7] A meta-analysis of 54 studies looking at infections inside houses where people live together, involving nearly 78,000 participants, found that asymptomatic or pre-symptomatic index case transmission was 0.7%. In other words, 1 asymptomatic person would need to encounter about 140 people INSIDE A HOUSE for them to infect another. The chance of infection when in larger areas (e.g., stores) and particularly when outside is far less, to the extent that you may need to encounter thousands of people before infecting another.

[8] Post-lockdown SARS-CoV-2 nucleic acid screening in nearly ten million residents of Wuhan, China shows no asymptomatic transmission. The citywide screening of SARS-CoV-2 infection in Wuhan recruited nearly 10 million people, and found no newly confirmed cases with COVID-19. All close contacts were studied and virus cultures were negative for all asymptomatic positive and repetitive cases, indicating no viable virus in positive cases detected in this study.

[9] Another study concluded "that the infectivity of some asymptomatic carriers is weak."

[10] As you can see, I am declining this for multiple reasons; the science is overwhelmingly against these testing strategies and asymptomatic transmission.

The NHS Code of Conduct states:

"Refusal or withdrawal of treatment must, if challenged, be justified on the grounds of the best interests of the patient, or medical effectiveness, or on the basis of a rational, reasonable, proportionate and fair priority scheme for the use of available resources."

I am writing to inform you that I do not give my consent to the SARS-CoV-2 test. I am declining this on ethical reasons.

There are many reasons why I do not give my consent to be tested, but my main motive is for health reasons.

1. The testing swabs are sterilised in Ethylene Oxide, which has been labeled a Group 1 Carcinogen, the most potent form of cancer causing chemical.
2. As well as this major health hazard, there are other detrimental side effects from short term exposure to ethylene oxide which include eye and upper respiratory tract irritation, nausea, vomiting, diarrhoea, headache, dizziness, malaise, fatigue, muscle weakness, and signs and symptoms of peripheral neuropathy.
3. Medical ethics aside, the Covid-19 RT PCR tests, are highly inaccurate - this has been shown by many medical experts over the last 12 months.
4. The fact that it has such a high false positive rate can be detrimental to myself and my families physical and mental health. If I test positive, although likely to be a false positive, it would mean that my whole family would have to self-isolate for 10 days. The mental health of myself and my family cannot sustain reoccurring isolations, based both on the grounds of "health", but economically as well.

I would like to state that if I did become symptomatic, that I would self-isolate immediately and tell anyone who I have been in contact with.

As per my Unalienable Rights (freedom of travel) I will be taking legal action if I am restricted from travel because of this.

If warrant (card) is provided, continue with below.

"You swear an Oath to uphold the constitution, the constitutions
which are brought into existence under Natural Law which is stated
in your pre-amble, which means the Government can bring in
nothing to infringe on our freedom to travel."

"Are you under Oath?" "Yes or no?"

"I have the right to video if you are committing a crime as a servant,
civil servant, or an oath taker paid a salary from the Government,
paid for by the people.

You usually see the ALL CAPITALS or UPPERCASE text found as a language when writing in the American Sign Language (ASL). This is a signing language used for the deaf when written down. ASL can be defined in the book The Chicago Manual of Style under the foreign languages header: American Sign Language (ASL) compound signs, 10.152 and 'glosses, 10.147'. Thus, defining this text as a foreign language.

It also goes on to say that when written, it has no one to one correspondence with any other languages on the document. The all CAPS or Gloss is also found in the Oxford Styles Manual under foreign-languages, namely Ancient Latin, however as the all caps UK LTD is registered in Washington D.C, they appear to be using the 'Chicago Manual of Style', not the Oxford styles manual version.

Putting two or more languages onto a legal document is known in law as a 'Glossa'. Black's Law Dictionary defines: 'GLOSSA' - "It is a poisonous gloss which corrupts the essence of the text". Meaning that by using the Glossa in a document they are trying to conceal

PERMISSIBLE MEDICAL EXPERIMENTS

The great weight of the evidence before us is to the effect that certain types of medical experiments on human beings, when kept within reasonably well-defined bounds, **conform to the ethics of the medical profession generally**. The protagonists of the practice of human experimentation justify their views on the basis that such experiments yield results for the good of society that are unprocurable by other methods or means of study. All agree, however, that certain basic principles must be observed in order to satisfy moral, ethical and legal concepts:

1. **The voluntary consent of the human subject is absolutely essential.**

This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, **without the intervention of any element of force, fraud, deceit, duress, over-reaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision**. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment.

The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs or engages in the experiment. **It is a personal duty and responsibility which may not be delegated to another with impunity.**

2. **The experiment should be such as to yield fruitful results for the good of society, unprocurable by other methods or means of study, and not random and unnecessary in nature.**

3. **The experiment should be so designed and based on the results of animal experimentation and a knowledge of the natural history of the disease or other problem under study that the anticipated results will justify the performance of the experiment.**

4. **The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury.**

5. **No experiment should be conducted where there is an a priori reason to believe that death or disabling injury will occur; except, perhaps, in those experiments where the experimental physicians also serve as subjects.**

6. **The degree of risk to be taken should never exceed that determined by the humanitarian importance of the problem to be solved by the experiment.**

7. Proper preparations should be made and adequate facilities provided to protect the experimental subject against even remote possibilities of injury, disability, or death.

8. The experiment should be conducted only by scientifically qualified persons. The highest degree of skill and care should be required through all stages of the experiment of those who conduct or engage in the experiment.

9. During the course of the experiment the human subject should be at liberty to bring the experiment to an end if he has reached the physical or mental state where continuation of the experiment seems to him to be impossible.

10. During the course of the experiment the scientist in charge must be prepared to terminate the experiment at any stage, if he has probably cause to believe, in the exercise of the good faith, superior skill and careful judgment required of him that a continuation of the experiment is likely to result in injury, disability, or death to the experimental subject.

Of the ten principles which have been enumerated our judicial concern, of course, is with those requirements which are purely legal in nature—or which at least are so clearly related to matters legal that they assist us in determining criminal culpability and punishment. To go beyond that point would lead us into a field that would be beyond our sphere of competence. However, the point need not be labored. We find from the evidence that in the medical experiments which have been proved, these ten principles were much more frequently honored in their breach than in their observance. Many of the concentration camp inmates who were the victims of these atrocities were citizens of countries other than the German Reich. They were non-German nationals, including Jews and “asocial persons,” both prisoners of war and civilians, who had been imprisoned and forced to submit to these tortures and barbarities without so much as a semblance of trial. In every single instance appearing in the record, subjects were used who did not consent to the experiments; indeed, as to some of the experiments, it is not even contended by the defendants that the subjects occupied the status of volunteers. In no case was the experimental subject at liberty of his own free choice to withdraw from any experiment. In many cases experiments were performed by unqualified persons; were conducted at random for no adequate scientific reason, and under revolting physical conditions. All of the experiments were conducted with unnecessary suffering and injury and but very little, if any, precautions were taken to protect or safeguard the human subjects from the possibilities of injury, disability, or death. In every one of the experiments the subjects experienced extreme pain or torture, and in most of them they suffered permanent injury, mutilation, or death, either as a direct result of the experiments or because of lack of adequate follow-up care.

Obviously all of these experiments involving brutalities, tortures, disabling injury, and death were performed in complete disregard of international conventions, the laws and customs of war, the general principles of criminal law as derived from the criminal laws of all civilized nations, and **Control Council Law No. 10. Manifestly human experiments are contrary to “the principles of the law of nations as they result from the usages established among civilized peoples, from the laws of humanity, and from the dictates of public conscience.”**

Notarised Affidavit of Religious Belief for Exemption from COVID Vaccination

1) I, am a practicing Catholic, and my belief is sincere and meaningful.

2) The Catholic church has, over the centuries, extensively addressed issues related to bodily integrity generally and vaccination specifically, including issues of voluntariness and vaccine mandates.

3) Regarding COVID in particular, the Congregation for the Doctrine of the Faith (CDF) published a "Note on the morality of using some anti-Covid-19 vaccines" on December 21, 2020, stating that:

a) COVID-19 vaccines that used cell lines originating from aborted fetuses are morally compromised. [Note: The J&J vaccine "is an adenoviral vector grown in the PER.C6 cell line that originated from a healthy 18-week-old aborted child." The Pfizer and Moderna vaccines were tested using the "morally compromised HEK-293 cell line," originating from "a child aborted in the Netherlands in 1972."]

Catholics have a moral duty to avoid use of such vaccines.

b) However, this moral duty "is not obligatory if there is a grave danger, such as the otherwise uncontainable spread" of COVID-19.

c) "In the absence of other means to stop or even prevent the epidemic, the common good may recommend vaccination."

d) "In such a case, all vaccinations recognised as clinically safe and effective can be used in good conscience." e) "At the same time,

practical reason makes evident that vaccination is not, as a rule, a moral obligation and that, therefore, it must be voluntary."

f) "Those who, [...] for reasons of conscience, refuse vaccines produced with cell lines from aborted fetuses, must do their utmost to avoid, by other prophylactic means and appropriate behaviour, becoming vehicles for the transmission of the infectious agent."

4) To summarise, the moral duty to avoid use of these three COVID vaccines is not obligatory only if:

a) The spread of COVID-19 is otherwise uncontainable, b) There is an absence of other means by which to stop or prevent the epidemic,

c) The vaccines are clinically safe, and

d) The choice to receive a vaccine must be voluntary.

5) If any element is not satisfied, the moral duty to avoid using the vaccines is obligatory.

In which case, _____'s vaccine mandate violates my Catholic faith.

6) Even if all elements were satisfied, a non-obligatory moral duty does not equate to me taking a vaccine, much less authorising a vaccine mandate. It merely means that, as a Catholic, I have the option to evaluate the evidence myself and make my own prudential decision whether to receive a vaccine; to repeat, "it must be voluntary." I can choose to not take a vaccine, in which case I must "avoid, by other prophylactic means and appropriate behaviour, becoming [a] vehicle for the transmission of the infectious agent."

7) Here, all four elements have yet to be satisfied.

8) The threshold issue is voluntariness: "vaccination is not, as a rule, a moral obligation and [...], therefore, it must be voluntary." This mandate violates my Catholic faith because it is, by definition, not voluntary.

9) Rather than a coercive mandate, _____ should emphasise the virtue of Prudence, allowing each student/employee to make a prudential decision whether to take a COVID vaccine. Failing this, _____ should follow the science by changing the mandate to acknowledge two additional "means by which to stop or prevent the epidemic," two additional forms of protection that are equivalent to or greater than protection gained via some or all of the three COVID vaccines:

a) Naturally acquired immunity via prior COVID infection and subsequent recovery; and b) Prophylactic ivermectin, taken weekly in accordance with the FLCCC Alliance protocol.

10) Consistent with the CDF note, I am already taking the most effective "other prophylactic means" as an alternative to vaccination: ivermectin taken weekly as a prophylactic, per the FLCCC Alliance protocol. Regarding ivermectin's efficacy against COVID, as both prophylaxis and treatment, please see the attached 4-page summary.

11) If _____ decides to acknowledge the ivermectin evidence and allow this form of protection as an alternative to vaccination, I am willing to sign something weekly verifying that I am taking the medication.

12) Furthermore, there is evidence that the three COVID vaccines are not clinically safe. The AMERICA'S FRONTLINE DOCTORS, et al. v. XAVIER BECERRA, Secretary of the U.S. Department of Health and Human Services, et al. complaint mentions some of this evidence,

pericarditis in young men, per the CDC.

13) The most concerning piece of evidence is a graph created using data from Pfizer (next page). As background:

a) All three vaccines utilise the Spike protein. Recent studies, indicate the Spike protein alone (without coronavirus infection per se) is enough to cause damage, inducing symptoms similar to catching COVID-19. This fact appears to have come as a surprise to the vaccine developers.

b) The three vaccines were designed to anchor the Spike protein to the cell; the Spike protein was not supposed to flow freely in the blood. 14) However, the Pfizer data (chart on next page) show something different happening in reality:

a) During the initial 8 hours after injection, the Spike protein is flowing freely in both the blood plasma and whole blood. This indicates that the "anchoring" did not work. This was not supposed to happen.

b) The Spike protein is then concentrating in both the ovaries and bone marrow. This was not supposed to happen either. The Spike protein was supposed to end up in the liver to "get chewed up by various destructive enzymes."

15) Thus far, there is only one year of data available on these three vaccines; nobody knows what the long-term effects will be. This makes Point 14(b) particularly concerning. Concentration of the Spike protein in the ovaries suggests infertility or birth defects as long-term effects, and concentration in the bone marrow suggests leukemia or autoimmune disorders.

16) As a Catholic, I support life. This position is not limited to opposing abortion; it extends to opposing both COVID vaccines tested using aborted fetal cell lines and a vaccine mandate that may, based on available evidence, cause infertility in females and/or birth defects in future children.

17) 's vaccine mandate applies to both males and females. As a Catholic, I believe that any risk of infertility for anyone - is an unacceptably high risk. Forcing female students/employees to take this risk by mandating vaccination when the safer alternative of prophylactic ivermectin is available and known is unethical, inhumane, illegal, and in violation of my Catholic faith. should eliminate its vaccine mandate, but failing that, female students/employees should be exempted from the mandate.

THE INTERNATIONAL CODE OF MEDICAL ETHICS DRAFTED BY THE WMA DEVELOPS THE FOLLOWING PRINCIPLES AND OBLIGATIONS:

- **Obligation of care:** The obligation not to refuse care to those who need it and not to discriminate on financial or other grounds is linked to the obligation to respect life and to consider emergency care as a humanitarian duty. This ethical obligation may also be found in criminal law under the offense of failure to assist a person in danger. The obligation to provide medical care compels doctors to act in the exclusive interest of patients
- **Respect of patients' consent:** The obligation to inform the patient and to obtain and respect his or her consent before any act of care is paramount in order to protect the balance in the relationship between the doctor and the patient, and to ensure that the patient's dignity is respected. This obligation puts the power that the doctor has over the patient into perspective. Even if the doctor must always act in the patient's best interest, he cannot substitute himself for the patient and decide what the patient wants. This duty is well spelled out in most national laws, and gives rise to compensation before courts.

THE NUREMBERG CODE (1947)

Permissible Medical Experiments:

The great weight of the evidence before us to effect that certain types of medical experiments on human beings, when kept within reasonably well-defined bounds, conform to the ethics of the medical profession generally. The protagonists of the practice of human experimentation justify their views on the basis that such experiments yield results for the good of society that are unprocurable by other methods or means of study. All agree, however, that certain basic principles must be observed in order to satisfy moral, ethical and legal concepts:

- The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment.

The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs, or engages in the experiment. It is a personal duty and responsibility which may not be delegated to another with impunity.

- The experiment should be such as to yield fruitful results for the good of society, unprocurable by other methods or means of study, and not random and unnecessary in nature.
- The experiment should be so designed and based on the results of animal experimentation and a knowledge of the natural history of the disease or other problem under study that the anticipated results justify the performance of the experiment.
- The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury. o experiment should be conducted where there is an a priori reason to believe that death or disabling injury will occur; except, perhaps, in those experiments where the experimental physicians also serve as subjects.
- The degree of risk to be taken should never exceed that determined by the humanitarian importance of the problem to be solved by the experiment.
- Proper preparations should be made and adequate facilities provided to protect the experimental subject against even remote possibilities of injury, disability or death.
- The experiment should be conducted only by scientifically qualified persons. The highest degree of skill and care should be required through all stages of the experiment of those who conduct or engage in the experiment.
- During the course of the experiment the human subject should be at liberty to bring the experiment to an end if he has reached the physical or mental state where continuation of the experiment seems to him to be impossible.

- During the course of the experiment the scientist in charge must be prepared to terminate the experiment at any stage, if he has probable cause to believe, in the exercise of the good faith, superior skill and careful judgment required of him, that a continuation of the experiment is likely to result in injury, disability, or death to the experimental subject.

WHEREAS, physicians and other health care providers working on the front lines, utilising their knowledge of epidemiology, pathophysiology and pharmacology, are often first to identify new, potentially life saving treatments;
