#### To Whom It May Concern,

In accordance with the New World Alliances (NWA) Ordinance 2022–2027, international diplomatic laws, and applicable treaties, this document serves as an official assignment for **James Florance** to the position of **Global Head of Strategy & Planning** under the NWA Global Ambassadors Diaspora Program. As of this date, he is recognized as a Plenipotentiary ambassador and is entitled to all diplomatic privileges and immunities as provided under international law.

#### Assignment Overview

##### Mission Scope

James Florance is hereby assigned to a continuous **Global Diplomatic Assignment**, subject to review on **February 20, 2026**. - His primary responsibilities shall include:-

##### Mission Objective 1: Global Energy Innovation and Distribution

1. **Exploration of Global Opportunities:** Identify and assess potential partnerships with countries and international bodies to advance the adoption of sustainable energy solutions.
2. **Building Diplomatic Relations:** Engage governmental and non-governmental organizations to negotiate agreements for technology sharing, joint research projects, and investment in energy infrastructure.
3. **Funding and Investment:** Secure international funding streams through grants, development banks, private sector investments, and multilateral agreements.
4. **Capacity Building:** Support host nations in developing expertise in alternative energy through workshops, training, and technological exchanges.
5. **Advocacy and Awareness:** Promote sustainable energy policies in international forums to encourage policy shifts and increased public awareness.

##### Mission Objective 2: Humanitarian Relief Funding

1. **Funding Identification:** Research and establish new funding sources for humanitarian aid from international donors, private philanthropy, and corporate social responsibility initiatives.
2. **Partnership Development:** Foster relationships with UN agencies, NGOs, and global coalitions to align funding efforts with humanitarian needs.
3. **Long-Term Funding Strategies:** Develop sustainable financing models to ensure long-term humanitarian impact beyond immediate relief efforts.
4. **Innovation in Aid Delivery:** Explore new financial mechanisms such as humanitarian bonds and impact investing to maximize resource efficiency.

5. **Public Engagement:** Enhance global awareness and mobilization through diplomatic engagement, media outreach, and international advocacy campaigns.

### Diplomatic Immunities and Privileges

James Florance is entitled to all diplomatic immunities as recognized under international law, including but not limited to:

- **Vienna Convention on Diplomatic Relations (1961):** Providing immunity from legal jurisdiction and ensuring free movement in diplomatic functions.
- **Nuremberg Code & Universal Declaration of Human Rights:** Upholding personal sovereignty and safeguarding against coercive measures.
- **Ordinance Number PPCC (NWA 2022–2027):** Establishing protection from undue governmental interventions and upholding inalienable rights.
- **Magnitsky Act & Treaty of Rome (Articles 15.1 and 53):** Providing protection against human rights abuses and ensuring legal recourse against violations.

As a **Global Ambassador Diaspora**, James Florance shall be granted full diplomatic privileges, including exemption from local laws where applicable, protection under international treaties, and recognized status as an official representative of NWA.

### Enforcement and Compliance

This diplomatic assignment is legally binding and enforceable under international law. Any attempt to obstruct or hinder James Florance in the execution of his duties shall be deemed a violation of international human rights and diplomatic protocols. Non-compliance by any entity, institution, or government shall be classified as a breach of the **Universal Declaration of Human Rights** and the **Vienna Convention on Diplomatic Relations**.

As per the authority vested in the New World Alliances, this assignment remains in effect until formally revoked or renewed after the scheduled review on February 20, 2026.
