NEW WORLD ALLIANCES EARTH, FOOD AND WATER SOVEREIGNTY STEWARDSHIP ALLIANCES (EFWSSA) ORDINANCE GFPA 2025

PREAMBLE:

We, the New World Alliances (NWA), recognizing the divine, inherent, and inalienable rights of all individuals to cultivate, trade, and distribute food free from undue interference, hereby establish this ordinance to protect farmers, small holdings and domestic food growers, agricultural workers, food distributors, and consumers globally.

This ordinance is founded upon universally God-given inalienable human rights, natural law, sacred teachings, and established international legal frameworks to uphold food, water and agricultural sovereignty as a fundamental pillar of human freedom and survival.

Recognizing that the farmer is the foundation of civilization and the guardian of life, the New World Alliances (NWA) hereby enacts this Farmers Protection Ordinance GFPA 2025 to ensure the sovereignty, immunity, and perpetual security of farmers, their families, their land, their homesteads, their livestock and pets, and all biodiversity under their stewardship.

This ordinance asserts that any action against a sovereign farmer's land, produce, intellectual property, or livelihood shall be considered a violation of international law, an act of war under Article 51 of the UN Charter, and an attack on God-given inalienable human rights as per multiple legal, historical, and spiritual precedents.

STRATEGIC NOTE:

This ordinance may also serve as a Global Charter/Treaty on Food Sovereignty, providing a framework for international adoption, phased associates and allies, and enforceable protections.

NEW WORLD ALLIANCES EARTH, FOOD AND WATER SOVEREIGNTY STEWARDSHIP ALLIANCES (EFWSSA) ORDINANCE GFPA 2025

This ordinance is irrevocable, non-negotiable, and binding. It shall remain in full force and effect for a period of sixty (60) months - from 02 April 2025 through 02 April 2030 - with the registered issuance of honorable diplomatic immunity duly acknowledged and respected under applicable laws.

Article I - Scope of Authority

All institutions, governments, foundations, corporations, and all individuals employed within them are hereby mandated and ordered to comply with this ordinance. Compliance must be in effect immediately and no later than 23 October 2025.

Such compliance includes the full recognition, respect, and honoring of the God-given inalienable rights of all human beings, without exception.

Article II - Immunity and Protection

Any farmer, agricultural worker, or individual holding an officially issued Earth, Food, & Water Sovereignty Stewardship Alliances (EFWSSA) membership card under Section VII, Article 7.1 of the ordinance of the New World Alliances and/or certification under this ordinance shall be given:

- Full immunity as defined by the ordinance.
- Comprehensive protection of rights, property, and livelihood.
- Recognition and safeguarding under diplomatic protection mechanisms.

DANGEROUS FREEDOM OVER PEACEFUL SLAVERY

SECTION I: RIGHT TO FOOD PRODUCTION AND DISTRIBUTION

1.1 Recognition of Food Sovereignty

Every individual, family, and community possesses the God-given inalienable human right to:

- grow food,
- harvest crops,
- store and preserve agricultural produce,
- trade seeds and foodstuffs, and
- distribute food locally, regionally, and globally.

This right shall not be infringed upon by corporations, governments, financial institutions, or international entities seeking to monopolize, patent, privatize, or restrict food production and distribution.

Food sovereignty is hereby declared a fundamental God-given inalienable human right and divine mandate, essential to freedom, dignity, and survival.

1.2 Legal and Ethical Foundations

This ordinance draws upon the following legal, lawful, loreful, ethical, and spiritual authorities:

- Universal Declaration of Human Rights (UDHR, 1948), Article 25: affirms the right to adequate food, health, and well-being.
- International Covenant on Economic, Social, and Cultural Rights (ICESCR, 1966), Article II: recognizes the right to adequate food and obligates states to take proactive measures to combat hunger.
- UN Declaration on the Rights of Peasants (UNDROP, 2018), Article 15: protects the right to food sovereignty and ecologically sustainable production.
- The Holy Bible (Genesis 1:29): "I have given you every herb bearing seed... and every tree, in which is the fruit of a tree yielding seed; to you it shall be for meat." affirming divine intent for humanity's free access to food and seed.
- The Magna Carta (1215, Clause 61): enshrines the right to self-determination and economic independence, including the natural right to sustain one's household and community through agriculture.

- African Charter on Human and Peoples' Rights (1981), Article 21: guarantees peoples' right to freely dispose of their wealth and natural resources.
- Convention on Biological Diversity (1992) & Cartagena Protocol (2000): affirm precautionary principles, ensuring biodiversity protection and the free use of natural resources.

1.3 Protection of Small and Independent Farmers & any Food Grower

Governments, corporations, and international institutions shall not impose restrictions, taxation regimes, or policies that disproportionately harm:

- backyard food growers,
- small-scale farmers,
- large-scale farmers,
- indigenous agriculturalists, and
- organic and regenerative food producers.

The following practices are hereby declared protected rights under international God-given inalienble human rights law:

- Seed-saving: Farmers have the right to store, replant, and share traditional seeds free from criminalization or patent coercion.
- Natural and regenerative farming: Sustainable agricultural methods that protect biodiversity and soil health shall be safeguarded from interference by industrial agribusiness or synthetic mandates.
- Indigenous agricultural knowledge: Ancient and traditional farming practices shall be respected as cultural heritage and vital contributions to ecological balance and shall not be interfered with.

Legal Backing

- FAO International Treaty on Plant Genetic Resources for Food and Agriculture (2004): affirms farmers' rights to save, use, exchange, and sell farm-saved seed.
- UNDROP (2018), Article 19: guarantees farmers' right to maintain, control, and protect traditional seeds.
- ILO Convention 169 (1989): protects the land and resources of indigenous peoples against exploitation or coercion.
- Rome Statute of the ICC (1998), Article 7: criminalizes systemic acts that deprive populations of their livelihoods and survival resources.

SECTION II: TRADE AND DISTRIBUTION FREEDOM

2.1 Right to Free and Fair Trade

No nation, corporation, or trade agreement shall impose sanctions, tariffs, embargoes, or restrictions that deliberately hinder the free movement of food across borders or obstruct access to agricultural resources.

Any economic sanctions that intentionally cause food shortages or restrict agricultural commerce shall be classified as crimes against humanity, prosecutable under:

- The Rome Statute of the International Criminal Court (1998):
 - Article 7: Crimes against humanity, including inhumane acts causing great suffering or deprivation of essential resources.
 - Article 8: War crimes, prohibiting the starvation of civilians as a weapon of war.
- Geneva Conventions (1949) & Additional Protocol I (1977), Article 54: prohibits attacks on objects indispensable for survival, including food and crops.
- Universal Declaration of Human Rights (UDHR, 1948), Article 25: affirms the right to adequate food, clothing, and health.
- International Covenant on Economic, Social and Cultural Rights (ICESCR, 1966), Article II: establishes the right to adequate food and obliges states to ensure freedom from hunger.

Trade freedom in agriculture is thus a protected right under humanitarian and international law.

2.2 Prevention of Monopolistic Control

The consolidation of monopolistic control over food production, distribution, or seeds is expressly prohibited.

Legal and Moral Foundations

- Sherman Antitrust Act (United States, 1890): prohibits monopolies and anti-competitive practices in commerce. **AGEROUS FREEDOM OVER PEACEFUL**
- European Union Competition Law & Global Antitrust Statutes: safeguard against market manipulation and ensure fair competition.

- UN Declaration on the Rights of Peasants (UNDROP, 2018), Article 19: affirms farmers' right to seeds, protecting traditional practices from corporate monopolization.
- FAO International Treaty on Plant Genetic Resources for Food and Agriculture (2004): protects seed sovereignty and biodiversity from intellectual property restrictions.
- Convention on Biological Diversity (1992) & Cartagena Protocol on Biosafety (2000): ensure that GMOs and patents cannot override community rights and environmental sustainability.

Application

- GMO patents shall not be weaponized to suppress traditional agricultural methods, criminalize seed-saving, or enforce dependency upon corporations.
- Any corporation or institution found guilty of enforcing seed monopolies or coercive patents shall be subject to asset seizures, sanctions, and dissolution under international antitrust law.

2.3 Emergency Food Access Protections

In times of global or regional food crises, all embargoes, tariffs, or trade restrictions on essential foodstuffs are declared null and void under international humanitarian law.

Legal and Moral Foundations

- Geneva Conventions (1949) & Additional Protocol I (1977): prohibit the starvation of civilians and restrict actions that obstruct humanitarian food relief.
- Rome Statute of the ICC (1998), Articles 7 & 8: classify deliberate obstruction of food supply in emergencies as crimes against humanity and war crimes.
- Universal Declaration of Human Rights (UDHR, 1948), Article 25: affirms the right to food in all circumstances.
- UN Sustainable Development Goal 2 (2015): commits states to achieving food security and ending hunger globally.

Decentralized Solutions

- Decentralized, community-based distribution networks shall be prioritized over vulnerable centralized global supply chains that have failed to protect food security.
- Local resilience, regional cooperation, and fair-trade alliances shall ensure emergency food access beyond political and corporate interference.

SLAVERY

2.4 Farm-to-Table Protection

It is hereby declared that restaurants, schools, and community centers shall retain the right to purchase and serve foods sourced directly from local farmers and food growers. Any prohibition of such practices, including corporate mandates requiring exclusive use of industrially produced food, is unlawful and void. The farm-to-table concept is to be preserved as a matter of consumer choice and cultural sovereignty, rather than corporate dictate.



SECTION III: LEGAL PROTECTIONS AGAINST OPPRESSION AND COERCION

3.1 Protection Against Unjust Land Seizures

No government, international financial institution, or corporation shall unlawfully seize land under false pretenses, whether by declaring eminent domain, manipulating debt restructuring, or disguising corporate land-grabs as so-called "green initiatives."

Such actions shall constitute crimes against humanity and may be referred to the International Criminal Court (ICC) for prosecution or other prosecutorial organizations or institutions.

Legal and Moral Foundations

- Universal Declaration of Human Rights (UDHR, 1948), Article 17: affirms the right to own property and prohibits arbitrary deprivation of property.
- International Covenant on Civil and Political Rights (ICCPR, 1966), Article 1: affirms all peoples' right to freely dispose of their natural wealth and resources without interference.
- UN Declaration on the Rights of Indigenous Peoples (UNDRIP, 2007): protects indigenous communities against forced displacement and land theft under the guise of development or conservation.
- African Charter on Human and Peoples' Rights (1981), Article 21: affirms the right of peoples to free disposal of their natural resources and protection against exploitation.
- Rome Statute of the International Criminal Court (1998), Articles 7 & 8: classify forced displacement and deprivation of resources essential for survival as crimes against humanity and war crimes.

Allodial Title Reinforced

The principle of Allodial Title—true, sovereign land ownership free from external liens or interference—must be upheld.

No debt instrument, corporate policy, or governmental decree may supersede the God-given inalienable human right of individuals and communities to their land, inheritance, and sacred territories.

3.2 Resistance to Forced Industrialization of Agriculture

No small, or mid-scale, or large farmer, or backyard grower shall be coerced, pressured, or mandated into:

- adopting synthetic fertilizers that harm soil and ecosystems,
- planting genetically modified crops (GMOs) against their will, or
- submitting to non-sustainable, extractive agricultural practices that erode biodiversity, sovereignty, or food security.

Such coercion is prohibited under binding international law and universally recognized declarations, including but not limited to:

Legal and Moral Foundations

- The Nuremberg Code (1947), Article 6, Section 3: Prohibits coercion in any form of experimentation, including medical or agricultural. The forced imposition of genetically modified seeds, pesticides, or experimental fertilizers constitutes non-consensual experimentation upon populations, thereby violating natural and international law.
- UN Declaration on the Rights of Peasants (UNDROP, 2018)
 - Article 15: Right to food sovereignty, healthy food, and ecologically sustainable practices.
 - Article 19: Right to seeds, and protection from contamination, coercion, or corporate seed dependency.
- Universal Declaration of Human Rights (1948), Article 25 affirms the right of every person to adequate health and food, which extends to freedom from corporate or governmental coercion into harmful or experimental practices.
- International Covenant on Economic, Social and Cultural Rights (1966), Article II: Recognizes the right to adequate food and requires governments to respect farmer sovereignty.
- Convention on Biological Diversity (1992) & Cartagena Protocol on Biosafety (2000): Require precautionary principles regarding genetically modified organisms (GMOs), protecting biodiversity and ensuring informed consent of communities and states before GMO introduction.
- FAO International Treaty on Plant Genetic Resources for Food and Agriculture (2004): Protects farmer seed sovereignty, traditional practices, and prohibits undue dependency on patented or monopolized seed technologies.
- The Stockholm Declaration on the Human Environment (1972) & Rio Declaration (1992): Recognize the precautionary principle and the obligation to protect ecosystems from industrial harm.

Application of Justice

- Freedom of choice: Farmers retain the God-given inalienable human right to choose natural, traditional, and sustainable farming methods without interference.
- Prohibition of coercion: Any government, corporation, or institution attempting to impose GMOs, pesticides, or industrial methods without consent shall be in violation of the Nuremberg principles and guilty of agricultural experimentation without consent.
- Accountability: Those responsible may be prosecuted under:
 - The Rome Statute of the ICC, for crimes against humanity when coercion causes systemic harm.
 - The Global Magnitsky Act and equivalents, for sanctioning individuals and corporations complicit in coercive agricultural practices.
- Protection of members: Holders of the New World Alliances' Earth, Food & Water Sovereignty Stewardship Alliances (EFWSSA) membership card and certifications under Section VII, Article 7.1 of the GFPA 2025 Ordinance shall be afforded full diplomatic protection against coercion and interference, under the authority of this GFPA 2025 ordinance.

3.3 Criminalization of Food Supply Manipulation:

Any deliberate destruction of crops, restriction of access to water, excessive or unsafe deployment of pesticides, or artificial inflation of food prices shall constitute economic warfare and be prosecuted as a crime against humanity and war crime under applicable international law, including the Rome Statute of the ICC and the Geneva Conventions.

- Furthermore, such acts shall trigger accountability measures under the Global Magnitsky Act and its international equivalents, enabling the sanctioning of responsible officials, institutions, and corporations through travel bans, asset freezes, and prosecution.
- The New World Alliances recognizes and enforces all relevant global instruments, including the UNDROP Declaration, the Universal Declaration of Human Rights, the International Covenant on Economic, Social and Cultural Rights, and the Stockholm Convention on Persistent Organic Pollutants, to ensure protection of food sovereignty, ecological health, and the God-given inalienable human rights of all peoples.

Any of the following deliberate acts shall be defined as economic warfare and prosecuted as a crime against humanity:

- destroying crops,
- restricting or diverting access to clean water,
- introducing unsafe or excessive pesticides, chemicals, or genetically engineered toxins, or
- artificially inflating the price of food and essential agricultural goods.

Such actions directly violate:

- The Rome Statute of the International Criminal Court (1998), Articles 7 and 8 (prohibiting extermination, starvation, and attacks against essential civilian survival).
- The Geneva Conventions and Additional Protocol I (1949, 1977), Article 54 (prohibiting destruction of food, crops, and water supplies).
- The Global Magnitsky Human Rights Accountability Act (2016, and international equivalents in the EU, UK, Canada, and Australia), which provides for sanctions, asset freezes, and travel bans against individuals and entities responsible for systemic God-given inalienable human rights abuses and corruption, including the deliberate manipulation of food supply chains.
- The UN Declaration on the Rights of Peasants (UNDROP, 2018), affirming the rights of farmers and rural workers to food sovereignty, safe ecological farming, and protection from seed and chemical monopolization.
- The Universal Declaration of Human Rights (1948), Article 25, and the International Covenant on Economic, Social and Cultural Rights (1966), Article II, affirming the right to adequate food and freedom from hunger.
- The Stockholm Convention on Persistent Organic Pollutants (2001), prohibiting the use of harmful pesticides and toxic chemicals that destroy ecological and human health.

Application of Justice

- Individual liability: Government officials, corporate executives, scientists, policymakers, and financial stakeholders who authorize or profit from such acts shall be held individually liable.
- Corporate and institutional liability: Corporations, foundations, and institutions found complicit in food manipulation or pesticide abuse shall be subject to seizure of assets, trade sanctions, and international blacklisting.
- Diplomatic enforcement: Holders of New World Alliances' Earth, Food & Water Sovereignty Stewardship Alliances (EFWSSA) membership card and certifications under Section VII, Article 7.1 of the GFPA 2025 Ordinance shall be afforded full diplomatic immunity and protection against coercion and interference, under the authority of this GFPA 2025 Ordinance. Any violation against them shall trigger sanctions under the Magnitsky Acts and referral to the ICC or other prosecutorial entities for prosecution.

DANGEROUS FREEDOM OVER PEACEFUL

3.4 Right to Soil Remediation and Regeneration

Farmers retain the sovereign right to recondition and regenerate their soil through natural remediation practices, including but not limited to composting, cover cropping, probiotic and microbiome restoration, and the reintroduction of minerals leached through chemical dependency. These rights are guaranteed regardless of government or corporate interference, ensuring that farmers can restore soil to a healthy, nutrient-rich condition, thereby producing food of high mineral and vitamin content, free from contamination, and profitable without corporate manipulation.

3.5 Synthetic Chemical Prohibition

Synthetic chemicals are hereby recognized as primary contributors to the destruction of soil microbiomes, mineral chelation, and possible chronic disease in humans. Farmers shall not be coerced, mandated, or incentivized into using chemicals. Any enforcement of such practices constitutes non-consensual experimentation, in direct violation of the Nuremberg Code (1947), and is classified as agricultural biowarfare.

- Genesis 2:15 (Bible) "The Lord God took the man and put him in the Garden of Eden to work it and take care of it." Humanity's divine mandate to steward and regenerate soil and life.
- Leviticus 25:23-24 (Bible) "The land shall not be sold permanently, for the land is Mine." Land and soil cannot be permanently alienated or poisoned.
- Deuteronomy 11:14 (Bible) "Then I will send rain for your land in its season... that you may gather in your grain, your wine, and your oil." Soil health tied directly to divine provision.
- Qur'an 2:164 "And in the earth are tracts diverse though neighboring, gardens of vines, fields sown, and palms in pairs and single... Verily in these are signs for those who reflect."
 Soil biodiversity is divinely ordained.
- Qur'an 6:141 Prohibits wastefulness and mandates ethical farming.
- Hindu Vedas (Atharva Veda, Book 12.1 "The Hymn to the Earth") Describes the Earth as mother and healer, whose soil must be replenished and cared for.
- Buddhist Aggañña Sutta (Digha Nikaya 27) Speaks of humanity's fall through greed leading to soil depletion, emphasizing the need for balance with the earth.
- Indigenous Teachings:
 - North American First Nations "Seventh Generation Principle" Land stewardship must protect soil and water for at least seven generations ahead.
 - o Tangat Whenua [Māori] Aotearoa [New Zealand] Whakapapa & Kaitiakitanga Soil, land, and water are living ancestors; humans are guardians, not owners.
 - African Ubuntu Soil Traditions Communal responsibility for fertile land as life-giving heritage.


SECTION IV: IMPLEMENTATION AND ENFORCEMENT

4.1 Establishment of the Earth, Food & Water Sovereignty Stewardship Alliances (EFWSSA) under GFPA 2025

- This ordinance establishes the New World Alliances' Earth, Food & Water Sovereignty Stewardship Alliances (EFWSSA) membership card and certifications under Section VII, Article 7.1 of the GFPA 2025, a worldwide coalition dedicated to enforcing the provisions of this ordinance and ensuring farmers', food and water rights remain protected.
- The New World Alliances' Earth, Food & Water Sovereignty Stewardship Alliances (EFWSSA) membership card and certifications under Section VII, Article 7.1 of the GFPA 2025, shall work in conjunction with the New World Alliances Global Ambassador Diaspora to advocate for legislative protection of food, water, farming, and agricultural sovereignty.

4.2 Legal Recourse and Accountability:

• Nations, corporations, or entities violating this ordinance may be held accountable in international courts and may be subject to trade embargoes and financial sanctions by participating nations/members.



SECTION V: SOVEREIGNTY & TRUSTEESHIP

5.1 Sovereign Title of Farmers

Farmers under the New World Alliances' Earth, Food & Water Sovereignty Stewardship Alliances (EFWSSA) membership card and certifications under Section VII, Article 7.1 of the GFPA 2025 Ordinance are hereby declared sovereign stewards of the land, endowed with inherent, irrevocable, and God-given inalienable human rights over their land, produce, seeds, and livestock.

No government, corporate entity, financial institution, or international body shall claim ownership, liens, taxation, or regulatory authority over a farmer's property without absolute, voluntary, and informed consent.

5.2 Sovereign Agricultural Trust (SAT)

Farmers may voluntarily elect to place their land into a New World Alliances-backed Sovereign Agricultural Trust (SAT). The SAT is designed to:

- enhance land security and economic stability,
- protect multi-generational ownership, and
- negotiate, in good faith, with governments to secure tax incentives, temporary exemptions, or subsidies tailored to applicable local laws.

This ensures financial relief for farmers while respecting national applicable frameworks and preserving sovereign autonomy.


5.3 Legal Immunity from Fraudulent Liens

Any lien, mortgage, or financial claim imposed upon a farmer's land without their voluntary agreement is hereby declared fraudulent, unlawful, and nullified under this GFPA 2025 Ordinance.

Precedents & Authorities:

- Magna Carta (1215, Clauses 39 & 61): protection against arbitrary seizure of property.
- Treaty of Westphalia (1648): affirmation of sovereignty and self-determination.
- Universal Declaration of Human Rights (UDHR, 1948), Article 17: right to property without arbitrary deprivation.

- African Charter on Human and Peoples' Rights (1981), Article 21: free disposal of natural resources by the people.
- Qur'an 2:188: "Do not consume one another's wealth unjustly..."
- Leviticus 25:23: "The land shall not be sold permanently, for the land is Mine."



SECTION VI: INTELLECTUAL PROPERTY RIGHTS (IPR) & TRADE SECRETS

6.1 Protection Against Seed Piracy

Farmers maintain exclusive intellectual property rights over their seeds, crops, and traditional farming methods.

No corporation, government, or entity may patent, privatize, or monopolize native, heirloom, or indigenous plant genetics.

6.2 Biopiracy as a War Crime

Any unauthorized genetic modification, theft, or coercive licensing of farmers' seeds shall be classified as:

- biopiracy,
- a form of economic warfare, and
- a crime against humanity under international law.

6.3 Trade Secrets & Proprietary Farming Techniques

Farmers' proprietary agricultural methods, techniques, and ancestral knowledge are classified as protected trade secrets.

Any act of espionage, forced disclosure, or corporate interference may be handed over and be prosecuted as economic sabotage and intellectual theft.

Precedents & Authorities:

- Convention on Biological Diversity (1992), Articles 8 & 10: recognition of indigenous knowledge and biodiversity protection.
- Cartagena Protocol on Biosafety (2000): precautionary regulation of GMOs.
- TRIPS Agreement (1994), Article 27: recognition of intellectual property while protecting traditional knowledge.
- UNDROP (2018), Article 19: farmers' rights to seeds and seed sovereignty.
- Deuteronomy 22:9: "You shall not sow your vineyard with two kinds of seed..."

SECTION VII: SOVEREIGNTY & STEWARDSHIP

7.1 Establishment

The Earth, Food & Water Sovereignty Stewardship Alliances (EFWSSA) (replaces the Global Farmers Protection Alliance) is hereby established as a special membership body under the authority of the New World Alliances Ordinance GFPA 2025. Membership within this body confers recognition, protection, and promotion to all farmers, growers, and land stewards as sovereign custodians of Earth's soil, water, food, and produce.

7.2 Inherent Rights of Members

- 7.2.1 Right to the Soil

 Members are guaranteed the inherent right to the soil, including its microbiome, fertility, and restoration.
 - References: Genesis 2:15 ("Man was placed in the garden to till it and keep it"); Magna Carta (1215), Clause 47 (restoring rights to the commons).
- 7.2.2 Right to Water

 Members are guaranteed the right to access, use, preserve, and purify water as a divine and

natural inheritance.

- o References: UN General Assembly Resolution 64/292 (2010) recognition of water as a human right; John 4:14 (living water as sustaining life).
- 7.2.3 Right to Produce

All produce that emanates from the soil, livestock, or natural systems under stewardship is the lawful property of the cultivator and shall not be subject to unlawful seizure, liens, or corporate patent claims.

- References: Deuteronomy 28:12 ("The Lord will bless the work of your hands and your storehouses"); International Covenant on Economic, Social and Cultural Rights (ICESCR), Article II (right to adequate food).
- 7.2.4 Right to Fair Exchange & Distribution

 Members are guaranteed the right to exchange, barter, and distribute their produce freely, without coercion, monopolistic control, or unjust interference.
 - o References: Universal Declaration of Human Rights (UDHR), Article 23 (just conditions of work); Article 25 (adequate standard of living, including food).

- 7.2.5 Right to Farm & Cultivate Freely
 Members shall retain full autonomy to choose seeds, crops, livestock, cultivation methods,
 and natural inputs (including minerals, vitamins, supplements, herbs, and ecological
 practices) without interference.
 - o References: UN Declaration on the Rights of Peasants and Other People Working in Rural Areas (UNDROP, 2018), Articles 1–5 & 19 (right to seeds, biodiversity, and ecological methods).
- 7.2.6 Right to Membership & Collective Recognition
 Members are guaranteed the right to association and recognition through the New World
 Alliances' Earth, Food & Water Sovereignty Stewardship Alliances (EFWSSA) membership
 card and certifications under Section VII, Article 7.1 of the GFPA 2025 supported by a
 verified registry, QR-linked systems, and land-linked association if applicable.
 - References: Vienna Convention on Diplomatic Relations (1961) (recognition of sovereign association); UDHR, Article 20 (freedom of association).

7.3 Enforcement & Shield

Through QR-linked verification and land registry association (if applicable), the New World Alliances' Earth, Food & Water Sovereignty Stewardship Alliances (EFWSSA) membership card and certifications under Section VII, Article 7.1 of the GFPA 2025, affirms that no corporate, governmental, or financial entity shall unlawfully obstruct, seize, regulate, patent, or diminish these rights.

This body of New World Alliances' Earth, Food & Water Sovereignty Stewardship Alliances (EFWSSA) membership card and certifications under Section VII, Article 7.1 of the GFPA 2025 serves as a guardian of:

- Protection shielding members from unlawful seizure, coercion or manipulation.
- Preservation ensuring soil, water, and food systems remain sovereign and pure.
- Promotion advancing the prosperity, fair trade, and recognition of all sovereign farmers and stewards.
- References: Nuremberg Code (1947) free and informed choice in methods affecting human and ecological health; UN Declaration on the Rights of Indigenous Peoples (UNDRIP, 2007) rights to land, resources, and traditions; Declaration of Philadelphia (1944, ILO) labor, dignity, and freedom in economic life.

7.4 Supremacy of Sovereignty

All rights enumerated herein are irrevocable, inalienable, and supreme. They derive authority from natural law, divine law, and international precedent, and shall not be diminished by contemporary statutes, policies, or corporate agreements.

SECTION VIII: LAND, HOMESTEAD, & ENVIRONMENTAL IMMUNITY

8.1 Land as Untouchable & Inviolable

No farmer shall be forcibly removed from their land, nor subjected to eminent domain by governments or corporations.

8.2 Protection of Biodiversity

Livestock, pets, flora, fauna, et al under a farmer's stewardship are sacred and protected.

- forced culling,
- genetic tampering, or
- bio-engineered interference in farm ecosystems is strictly prohibited.

8.3 Geoengineering & Weather Warfare

Any attempt at weather modification - including enforced or coerced cloud seeding, drought induction, or climate manipulation - shall be classified as an act of war against farmers.

Precedents & Authorities:

- UN Convention on Environmental Modification (ENMOD Treaty, 1977): prohibits hostile weather manipulation.
- Qur'an 16:10: "He sends down water from the sky, and therewith We bring forth plants of every kind..."
- Psalm 104:14: "He makes grass grow for the cattle, and plants for people to cultivate."

• Rio Declaration on Environment and Development (1992): precautionary approach to environmental protection.

8.4 Right to Soil Microbiome Restoration

The soil microbiome is hereby recognized as essential to ecological and human health. Farmers are guaranteed the unrestricted right to restore soil ecosystems damaged by geoengineering, synthetic fertilizers, pesticides, or all chemical run-offs, (including biodegradable bait pellets). Denial of this right constitutes economic sabotage and environmental terrorism.

- 1. Convention on Biological Diversity (1992) Articles 8 & 10: obligations to conserve biodiversity and restore degraded ecosystems.
- 2. UN Convention to Combat Desertification (1994) Commitment to restore degraded soils and ensure sustainable land management.
- 3. Rio Declaration on Environment and Development (1992) Principle 15 (Precautionary principle); Principle 3 (intergenerational equity).
- 4. Universal Declaration of Human Rights (1948) Article 25: right to adequate food, health, and well-being.
- 5. International Covenant on Economic, Social and Cultural Rights (1966) Articles 11 & 12: right to adequate food and the highest attainable standard of health.
- 6. UN Declaration on the Rights of Peasants (UNDROP, 2018) Articles 15 & 19: right to ecologically sustainable production and protection from contamination.
- 7. Stockholm Declaration (1972) Principle 2: duty to protect natural resources, including soil, for future generations.
- 8. Genesis 2:15 (Bible) Mandate of stewardship: "The Lord God took the man and put him in the Garden of Eden to work it and take care of it."
- 9. Atharva Veda, Book 12.1 Hymn to the Earth (Hindu scripture) Reverence for Earth's soil as mother and healer.
- 10. Tangata Whenua [Māori] Principle of Kaitiakitanga Indigenous law of guardianship and stewardship of land and soil.
- 11. Haudenosaunee (Iroquois) Seventh Generation Principle Land and soil management must safeguard seven generations ahead.
- 12. Andean Pachamama Tradition Earth as a living mother requiring replenishment and balance.

SECTION IX: ACT OF WAR CLASSIFICATION

9.1 Invasion of Farmland

Any physical, digital, financial, or legislative encroachment upon farmland shall be deemed an act of war under Article 51 of the UN Charter, granting farmers the right to self-defense.

9.2 Biological Warfare Clause

The release of GMOs, pollutants, pesticides, biodegradable bait pellets, or bioweapons upon farmland constitutes bioterrorism and is prosecutable under international law.

9.3 Government Overreach & Economic Sabotage

Unjust taxation, forced regulation, or price controls targeting farmers shall be classified as economic warfare.

Precedents & Authorities:

- UN Charter, Article 51: inherent right of self-defense against aggression.
- Hague Convention (1907): prohibits destruction of civilian property during conflict.
- Rome Statute (1998), Articles 7 & 8: classifies systematic deprivation of resources as crimes against humanity and war crimes.



SECTION X: COMPENSATION FRAMEWORK FOR DAMAGES

10.1 Dollar-for-Dollar Restitution

Any farmer subjected to land seizure, forced culling, unjust loss, or financial sabotage shall receive full market value compensation plus punitive damages.

10.2 Asset Valuation & Documentation

Farmers shall be provided with a standardized Asset Valuation & Compensation Calculator, to document the item-by-item value of their property to:

- ensure transparency,
- prevent insurance fraud, and
- secure legal recourse.

10.3 International Arbitration & Legal Recourse

All disputes regarding land sovereignty or agricultural rights may be adjudicated through a New World Alliances Special Tribunal for Agricultural Sovereignty, recognized under international arbitration principles.

Precedents & Authorities:

- UNDROP (2018), Article 17: protection against arbitrary land expropriation.
- US Constitution (5th Amendment): "Nor shall private property be taken for public use without just compensation."
- Universal Declaration of Human Rights (1948), Article 17: protection against arbitrary property deprivation.



SECTION XI: LAND, WATER, & POLLINATOR PROTECTION

11.1 Land as Sacred Inheritance

Farmland shall remain untouchable and inviolable; eminent domain seizures are nullified under this ordinance.

11.2 Protection of Bees & Pollinators

The intentional destruction of bees or pollinators via pesticides, GMOs, chemicals or direct actions are hereby classified as environmental terrorism.

11.3 Sovereign Water Rights

Farmers shall maintain full sovereignty over all water sources on their land — wells, rivers, lakes, and rainwater.

Any privatization, contamination, or external regulation constitutes economic sabotage.

Precedents & Authorities:

- UN Convention on Biological Diversity (1992): protection of pollinators and biodiversity.
- Qur'an 16:68-69: "And your Lord inspired the bees..."
- Deuteronomy 11:14: "Then I will give you rain for your land in its season..."
- Hague Regulations (1907): protection of natural resources in conflict.

International Law & Treaties on Water Rights

- 1. Universal Declaration of Human Rights (UDHR, 1948) Article 25: right to an adequate standard of living, which includes access to water for health and well-being.
- 2. International Covenant on Economic, Social and Cultural Rights (ICESCR, 1966) Article 11 & 12: right to adequate food, health, and conditions of life; later expanded to explicitly include water.
- 3. General Comment No. 15 on the Right to Water (UN, 2002) water recognized as a fundamental human right, essential to life and health.

Indigenous Teachings on Water

- Haudenosaunee (Iroquois) Thanksgiving Address expresses gratitude for the waters as lifegivers that quench thirst and sustain all beings.
- Tangata Whenua [Māori], Aotearoa [New Zealand] Wai / Kaitiakitanga water is a living ancestor; guardianship over rivers, lakes, and springs is sacred duty.
- Australian Aboriginal "Caring for Country" rivers and waterholes are sacred Dreamtime sites, tied to law and life.
- Andean (Quechua & Aymara) Pachamama Traditions water is part of Earth Mother's sacred cycle; rivers and lakes are honored as living beings.
- Navajo (Diné) Teachings water (tó) is sacred, central to ceremony, healing, and harmony.

11.4 Soil Health & Regeneration Clause

Farmers could have full and unrestricted rights to soil health restoration, including remediation from chemical residues and fertilizers, and geoengineering contaminants. Any interference with these practices is null and void.

Legal & Treaty Backing

- 1. Convention on Biological Diversity (1992) obliges states to conserve biodiversity (soil microbiomes included) and restore degraded ecosystems (Articles 8, 10).
- 2. UN Convention to Combat rehabilitate degraded soils.

 Desertification (1994) requires nations to restore and rehabilitate degraded soils.
- 3. Rio Declaration on Environment & Development (1992)
 - Principle 15: Precautionary principle action must be taken to prevent environmental degradation even where full scientific certainty is lacking.
 - Principle 3: obligation to protect the environment for present and future generations.
- 4. Stockholm Declaration (1972), Principle 2 natural resources, including soil, must be safeguarded for future generations.
- 5. Universal Declaration of Human Rights (1948), Article 25 right to health and well-being, which cannot exist without clean soil and food.
- 6. International Covenant on Economic, Social and Cultural Rights (1966), Articles 11 & 12 requires states to guarantee adequate food and health, which depends on soil integrity.
- 7. UN Declaration on the Rights of Peasants (UNDROP, 2018), Articles 15 & 19 recognizes peasants' rights to ecologically sustainable production, clean environments, and traditional seed/soil practices.

8. Rome Statute of the ICC (1998), Articles 7 & 8 – systematic deprivation of resources essential for survival (such as deliberate soil poisoning) can be prosecuted as crimes against humanity or war crimes.



CONCLUSION: THE GOLDEN PEDESTAL FOR FARMERS

The Farmer or any grower of food is hereby declared the most protected individual within society. This New World Alliances' Earth, Food & Water Sovereignty Stewardship Alliances (EFWSSA) membership card and certifications under Section VII, Article 7.1 of the GFPA 2025 Ordinance establishes a fortified legal, spiritual, and economic shield ensuring that no government, corporation, or international body may interfere with the sovereign right to farm, live freely, and produce nourishing, chemical-free food for the people of Earth.

Farmers enrolled in this ordinance GFPA 2025 shall be afforded full diplomatic protection under the New World Alliances, and violations against them may be prosecuted as crimes against humanity under the highest legal/lawful/loreful authorities.



FINAL DECLARATION—SERVICE & NOTICE:

This ordinance is served upon ALL relevant public authorities, international and regional organizations, national ministries and regulators, corporate entities with material influence over land, seed, water, inputs, production, distribution and finance, defense and intelligence bodies with jurisdiction over climatic or geophysical operations, major medical, health and environmental institutions, and global religious and indigenous authorities for recognition. Named individuals and organizations materially implicated in agriculture, land, water, seed, pollinators, and trade have been individually served. Service is deemed effective upon transmission to the collective categories above and to the designated addressees within each category.
